4. First aid measures

7. Handling and storage

Handling

: Put on appropriate personal protective equipment (see section 8). Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. Contains gas under pressure. Avoid contact with eyes, skin and clothing. Avoid breathing gas. Protect cylinder from damage. Never attempt to lift a cylinder by its cap; the cap is intended solely to protect the valve. Never insert an object (e.g., wrench, screwdriver, pry bar) into cap openings; doing so may damage the valve and cause a leak. Use an adjustable strap wrench to remove over-tight or rusted caps. Open valve slowly. If valve is hard to open, discontinue use and contact your supplier. Close valve after each use; keep closed even when empty.

Storage

: Store in accordance with local regulations. Store in a segregated and approved area. Store in a dry, cool and well-ventilated area, away from incompatible materials (see section 10). Keep container tightly closed and sealed until ready for use.

Use a check valve or other protective device in any line or piping from the cylinder. Never work on a pressured system. If there is a leak, close the cylinder valve. Blow the system down in an environmentally safe manner in compliance with all federal, provincial, and local laws, then repair the leak. Never place a compressed gas cylinder where it may become part of an electrical circuit.

PRECAUTIONS TO BE TAKEN IN STORAGE:

Store and use with adequate ventilation. Firmly secure cylinders upright to keep them from falling or being knocked over. Screw valve protection cap firmly in place by hand. Store only where temperature will not exceed 52°C/125°F. Store full and empty cylinders separately. Use a first-in, first-out inventory system to prevent storing full cylinders for long periods.


